

FY23 Financial Overview*

Our financial position continues to be strong, thanks to the generosity of our donors. We put our resources to work to support local efforts to educate, advocate, and protect birds.



Revenue—Total: \$41,350

- \$26,366 Annual fund drive and other gifts
- \$6,202 National Audubon Support
- **\$4,549 -** Events and miscellaneous
 - \$4,233 Endowment income, interest

Expenses—Total: \$37,156

- \$15,800 Grants, sponsorships, honoraria


